

ANNUAL GENERAL MEETING 7 APRIL 2019

MINUTES

Meeting Commenced at 16.09 hrs at the Russell Boating Club

Present: 65 members with voting rights

1. Welcome:

The Commodore ("Jay") welcomed everyone to the Annual General Meeting.

Jay acknowledged the passing of a former member by the name of Andrew Pettit.

3. Approval of Minutes:

Jay moved that they be accepted, Jack seconded and all voted in favour of approving the two sets of minutes

3. Commodore's Report and Financial Report

- 3.1 The Commodore gave a brief overview of social events over the past year especially the Harry Lyon album launch, the annual cricket match and shipwreck ball.
- 3.2 Financial results for kitchen sales and bar were extremely good with both returning a really good profit. Expecting sales to grow with a strong team in the kitchen going forward.
- 3.3 The Club also had a fantastic racing programme this year. The racing aspect does not impact the Club financially and it is an important part of the club's year.
- 3.4 Youth sailing programme, for the first time, the Club ran a summer sailing programme with hired instructors. There was a charge for the lessons and the Club basically broke even.
- 3.5 Member subscriptions are increasing year on year, This year there are 365 members, 100 associate non-voting members and approximately 260 voting members
- 3.6 Tall ships regatta is the showcase event for the club and was very successful this year with a good number of entries. The hangi and kitchen were very busy and this year a professional band was hired for the marquee which encouraged the crowds to stay for longer.
- 3.7 Fundraising another really strong year for fundraising which comprised donations and grant money from various bodies
- 3.8 Putting it all together, this was another very strong year with \$44,130 cash profit. Another source of income was the slipway which has been operating throughout the year. The Club also received income from the showers, rented moorings and advertising in the calendar.
- 3.9 Unfortunately our expenses are also increasing with insurance premium, YNZ membership fees, electricity all increasing their prices. This illustrates that the Club has to keep income coming in to cope with increasing costs

3.10 Some of our profits were spent on capital expenditure, replacement pumps, bench refrigeration unit, deposit on trolley for slipway but we have a total of \$121,535 in the bank with the building fund now standing at \$41,193.

Jay was congratulated on improving the financial health of the club.

- 3.11 Jay then commented that he was keen on keeping membership rates low and food and drink prices affordable. Discussion also took place about the scheduling of the AGM but the thinking was that it be held in April so that more members can attend rather than hold it in winter when many members were overseas for the NZ winter.
- 3.12 Update on trolley replacement on slipway the Club has received funding of \$12,000 and donations of \$6,000 towards it. The project stalled over the winter and the hope is that it will still proceed with the new committee.
- 3.13 Update on race box and the wharf kiosk unfortunately the leaseholder told the club that it was no longer welcome to use the space due to tensions within the community. Plans to build a special tower or to include a race box with separate access into the new wharf building to enable the club to continue to use the space for racing in the future are under discussion with Far North Holdings.
- 3.14 Update on long term goal of lifting clubhouse it is a challenge to come up with an approach that everyone can agree with. The Club has a building sub-committee and several options are being investigated. The hope is that this process will continue with the new committee
- 3.15 Looking head, the next couple of years have the potential for being exciting. During 2021 the club is 50 years old. In he same year we will see the contest for the Americas Cup and also the Millenium Cup. The latter is probably of most interest as the Russell Boating Club is the club on record and it will be interesting to see to what extent the Club can become involved.
- 3.16 Jay finally commented that this event wrapped up his two years as Commodore and he acknowledged that it had been a meaningful two years and thanked everyone for their support

4. Matters arising

4.1 An opportunity had been presented to the club from the Russell Museum in relation to the Club's scrimshaw trophies being included in an upcoming exhibition to mark Tuia 250.

David outlined the proposal of the museum in relation to the tall ships trophies including insurance, display and proper acknowledgement of the Russell Boating

Club. The museum fully appreciates that these are the club's taonga. Christine Hall suggested that we should have a definite time frame for the display. She also commented that the Club does not display these trophies in a satisfactory way, partly due to lack of space and hopes that this is something that can be rectified in the future with the re-development of the Clubhouse.

After discussion, this issue was voted on by the members who agreed:

- (a) to release the trophies for a specified time on the understanding that they can be returned for the club to use when required;
- (b) that they be appropriately insured by the Museum; and
- (c) that there is a proper written agreement between the Club and the Museum.

The vote was passed by a majority show of hands
