Sump to be emptied after every 5 boats, used to be twice a year, now 5 or 6 times a year. Get rid of contaminated mud at bottom of slipway — can use shovels and wheelbarrows. Barry has talked with companies who do this work, but the digger is too big for our slipway. Ross Norman has a truck suitable for this work — he will send through a quote. Also need to keep an eye on drop sheets being used.
